### Free consultation and follow-up on simple matters

More than 75 percent of union members who have used the Legal Service did so at no cost. Benefits include:

- Free initial consultation of up to 30 minutes about almost any personal legal concern (over the phone or in person)
- Free simple legal document or contract review
- Free simple follow-up letter or phone call, if your attorney thinks it is likely to resolve your legal matter.

There is no limit to the number of free consultations, provided each is about a separate matter.

### 30% off additional services

If your legal concerns take more than the free consultation to address, you will receive a 30 percent discount off the attorney's regular hourly rates and flat fees. In contingency cases, where the attorney's fee is a percentage of any money received, the discount, if any, may be smaller.

### No enrollment or annual fees

Participation in this program is free for union members, their spouses and dependents. There aren't any enrollment forms to fill out, nor any enrollment fees.

### Attorneys carefully selected

Union Plus Legal Service attorneys are carefully screened and selected and have an average of 14 years of experience in active private practice.
